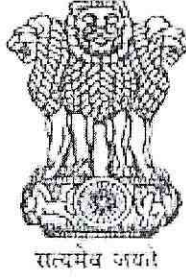

NOTIFICATION

The Principal Chief Commissioner of Central Goods and Service Tax, Vadodara Zone, Vadodara invites applications for recruitment of meritorious sportspersons in different games/sports. The posts are purely on temporary basis but likely to be made permanent. The recruitment will be made in following posts:

The candidate should be aged between 18-27 years. The crucial date for determining the age shall be the closing date for receipt of application from candidates i.e. 31.05.2021 Relaxation up to 3 years for OBC candidates and 5 years in case of SC/ST candidates. For exceptional achievements in Sports/Game and those candidates who fulfill all other eligibility conditions with necessary certificate, age will be relaxable up to 5 years and 10 years in case of SC/ST.

2. **SPORTS ELIGIBILITY:** The proficiency will be evaluated on the basis of their participation in recognized tournaments/events in the calendar year 2017, 2018,

2019 and 2020. Appointment can be made of a sportsman considered meritorious with reference to the following criteria:

- a) Sportsmen who have represented the country in the International competition.
- b) Sportsmen who have represented a State in the National competition.
- c) Sportsmen who have represented their University in the Inter-University Tournaments conducted by the Inter-University Sports Board.
- d) Sportsmen who have represented the State School Teams in the National Sports/games for schools conducted by the All India School Games Federation.
- e) Sportsmen awarded in physical efficiency performance conducted by Ministry of Education and Social Welfare.

4. SELECTION OF THE CANDIDATES:

(i) The application will be scrutinized and suitable candidates will be shortlisted for further selection process. The recruitment process will be in two phases. In the first phase, all the applicants will be ranked, based on their current form and achievements in the sports and games. For selection, the short-listed candidates are required to appear for following tests:

- A. Ground (Physical)/Proficiency Test**
- B. Written Test**

(ii) It is clarified that field trials will be conducted to check the fitness levels of the candidates and performance in the field trials will carry marks and will also count for ranking purpose. In case any candidate is unable to take fitness test for any reason whatsoever or having taken the test is not found fit, he would not be considered for appointment, despite his rank in the Select list. Also, the candidates who are not found fit in the field trials will not be considered for appointment. The current form will be evaluated based on the year of participation in recognised tournaments / events in the calendar year 2017, 2018, 2019 and 2020 for which the details should be furnished.

(iii) The shortlisted candidates will be called for written test. The written examination for the post of Tax Assistant will be in English and will consist of objective type multiple choice questions in General Knowledge, Numerical / Quantitative Aptitude, General English. Based on aggregate marks obtained in the field trials and written test, the candidates will be ranked for the selection.

Note: In case suitable candidates are not available in any of the above Games/Sports, the Department will not consider recruitment in that particular games/Sports.

(iv) Success in the above testes confers no right to appointment unless Department is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.

(v) The candidate after appointment has to pass the Departmental Computer Proficiency Test of 8000 Key depression per hour within a period of two years i.e. before completion of his/her probation, failing which the probation period will be extended.

5. How to apply: Application in prescribed format Annexure – I, Annexure – II (Form 1 to 5 as applicable) and Annexure III, duly signed and completed in all respect must be submitted to the “Additional Commissioner, Cadre Control Unit, CGST & Central Excise, 2nd Floor, GST Bhavan, Race Course Circle, Vadodara-390007” By post/by hand on or before **5:00 PM of 31.05.2021** (11.06.2021 for candidates domiciled in North – Eastern States, Andaman & Nicobar Island, Lakshadweep, Union Territories of Jammu & Kashmir and Ladakh). The candidates are requested to kindly read the Advertisement carefully and apply if eligible. The applications found ineligible will be liable for rejection and no communication will be made in this regard.

6. Eligibility of the candidates will be considered on the performance in the championships/events held on 01.01.2017 or afterwards only and sportsperson shall be currently active player. Performance in earlier championships/tournaments i.e. before 01.01.2017 will not be taken into consideration.

7. The candidates who are already employed with any government department should send their applications "Through proper Channel" only, failing which will be liable for rejection.
8. Selected candidates will be required to give an undertaking not to apply for inter-Commissionerate transfer for minimum period of 10 years.
9. Only attested copies of the documents in support of claim regarding Date of Birth, Educational Qualification, Sports Eligibility Certificates, Caste Certificate etc. should invariably be accompanied with the application.
10. In case of any applicants found submitting false/fabricated documents, the same will be viewed seriously and appropriate legal action will be initiated.
11. The candidate on appointment will be liable for posting at any place falls under CGST & CE and Customs, Combined Cadre of Gujarat Zone, Vadodara. The declaration to this effect to work at any place should be submitted alongwith the application.
12. Applications received after due date will not entertained under any circumstances. Incomplete and unsigned applications will be rejected and no correspondence in the matter will be made with the applicant. Eligible candidates will be called for above said tests. The date and venue for tests will be intimated to the eligible candidates in due course.
