- 2. **Age Limit:** Maximum age limit for applicants will be 40 years. However, relaxation can be accorded in deserving cases.
- 3. **Tenure:** The contractual engagement will be initially for a period of 02 (two) years or till the Khelo India Scheme continues, whichever is earlier, which can be further extended on the basis of performance.
- 4. Remuneration: Fixed monthly remuneration of Rs. 25,000/- i.e. Rs. 3 lakhs per annum.
- 5. Schedule of Walk-in-Interview: Date: 05.11.2020 Time: 11:00 A.M. onwards Venue: Directorate of Sports, Kurukshetra University, Kurukshetra.
- 6. Eligibility Documents: The eligible and interested candidates may report with their original educational, professional, Sports achievement certificates, ID proof/Aadhar Card alongwith an attested copy of the same at <u>Directorate of Sports(Kurukshetra University)</u>.
