**RECRUITMENT RALLY PROGRAMME UNDER UNIT HEADQUARTERS QUOTA**  
**WEF 03 JAN 2022 ONWARDS**

1. It is intimated that this Centre will be conducting Unit Headquarters Quota recruitment rally for all arms/service of **Soldier General Duty, Soldier Tradesmen Support Staff (ER) and Soldier Tradesmen (Chef)** at ASC Centre (North)-1ATC, Bengaluru-07 from 03 Jan 2022 onwards.
2. A leaflet containing the relevant details are enclosed herewith. The vacancies allotted are on **All India All Class (AIAC)** basis as per Directorate General Recruiting HQ of MoD (Army) letter No 63502/Rtg B (C) dt 15 Apr 2021 and even No dt 16 Sep 2021.
3. Only following category of personnel can participate in the recruitment rally :-
  - (a) Son of War Widow / Battle Casualty.
  - (b) Son of Widow of Servicemen/Ex-Servicemen.
  - (c) Son of Servicemen/Ex-Servicemen.
  - (d) Own brother of Servicemen.
  - (e) **Outstanding Sportsmen as open category are eligible for enrolment as Soldier General Duty (Dvr/MT) & Soldier General Duty (ASH) only.**
4. You are requested to give wide publicity so that maximum candidates are available for recruitment. Efforts should be made to motivate our Servicemen/Ex-servicemen to utilize these vacancies to the maximum.
5. Candidates have to appear for the physical tests at their own risk. Neither candidates nor their legal heirs are entitled to claim any compensation or other relief from the Government in case of any injury sustained due to undergoing any of the tests.
6. No travelling allowance / dearness allowance is admissible for candidates.
7. All candidates are advised to report at Gate No 5, ASC Centre (North) - 1 ATC, Bengaluru-07 at 0530h on 03 Jan 2022.
8. Please note that no personal application is required to be dispatch to this Centre. The candidates should directly report to Gate No 5, ASC Centre (North) - 1 ATC, Bengaluru on 03 Jan 2022 at 0530h with all requisite documents in original, as listed in the leaflet.

(c) **Priority 3 (Own Regt / Corps) (Serving / Ex-Serviceman).**

- (i) One son of serviceman who died in harness to include legally adopted son whose death is not attributed to military service.
- (ii) One son of serviceman / ex-serviceman to include legally adopted son.
- (iii) One brother of serviceman / ex-serviceman.

**Note.** Adoption done during the lifetime of a soldier will be valid for the purpose of award of bonus marks/concessions and enrolment through unit HQ quota enrolment.

(d) **Priority 4 (Other Regt/Corps).**

- (i) One son of War Widow to include legally adopted son.
- (ii) Real brother of Battle Casualty who marries the widow.
- (iii) One son-in-law of war widow having no son to include husband of legally adopted daughter.
- (iv) One real brother of unmarried Battle Casualty.

(e) **Priority 5 (Other Regt/Corps).**

- (i) In respect of Serviceman who dies in harness, one son/legally adopted Son or one real brother (if the serviceman is unmarried) where the widow/NOK is in receipt of Special Family Pension.
- (ii) One son/one legally adopted son of Ex-serviceman or one real brother (if the Ex-serviceman is unmarried) in receipt of Disability Pension more than 20% and the disability is attributed to/aggravated by Military Service.
- (iii) One son of Serviceman who dies in harness to include legally adopted son whose death is not attributed to Military Service.
- (iv) One son of Serving/Ex-serviceman to include legally adopted son.
- (v) One brother of serviceman / ex-serviceman.
- (vi) Wards of TA Pers.

5. The system of application & issue of call letters has been discontinued. Thereafter no application is required to be forwarded to the Centre for recruitment. The candidates should directly report to ASC Centre (North)- 1 ATC Bangalore at 0530h on 03 Jan 2022. The candidates should bring the following documents in original which are mandatory required at the time of screening and one set of photocopy of these documents self attested :-

(a) **Education Certificate.** SSLC / Matric / 10<sup>th</sup> / Secondary Certificates / Marks Sheet in Original issued by recognised State Board of Education.

(b) **Nativity / Permanent Residence/Domicile Certificate.** In Hindi/English duly signed by District Magistrate/SDM/DC/Tehsildar.

(c) **Caste Certificate.** Caste certificate duly signed by DM/SDM/BDO/Tehsildar/Officers so authorized for SC/ST/OBC. For General category candidates a certificate to this effect duly signed by Village Sarpanch/ Pradhan/Parshad is required on his letter pad. Sub caste, caste and class should be clearly mentioned in caste certificate.

(d) **Police Character Certificate.** With current photographs duly attested and signed by concerned Police station (Police Inspector/ Sub Inspector). Full name and designation of the officer issuing certificate and office round stamp must be recorded legible. Validity of the same is six month from the date of issue.

(e) **Character Certificates.** Character certificate duly affixed photograph of the candidate pasted on it and signed by authority of Village Sarpanch / Pradhan / School / College / Village Officer / Local Police Officer in Original. (Should not be more than six months old). Certificate in local language will not be accepted.

(f) **Unmarried and Married Certificate.** Unmarried/Married certificate with photograph of the candidate duly signed by Village Sarpanch / Pradhan / Village Officer stating that the individual is not married duly signed and stamped by authority (Should not be more than six months old (Performa as per Appendix 'A' attached). Married person below 21 years of age will not be eligible for recruitment except in case of brother of battle casualty married to widow of the battle casualty. If the candidate is married and above 21 years of age, marriage cert in original from the concerned authority alongwith six copies of recent joint photographs.



(g) **NCC Certificate in Original** in case of NCC candidates (A/B/C), if any.

(h) **Sports Certificate For Sportsmen Candidates Only.** Certificate of merit in sports / games of **International / National level**, if any. Sports certificate should be within three yrs between date of issue and date of screening of recruitment rally. Recruitment for following games only be carried out :-

(j) **Relationship Certificate.** Only one son and one brother are eligible to take part in a **UHQ Quota Rect Rally** vide LHQ of MoD (Army) Rtg B (A) letter No 62527/Rtg B (A) dt 20 Jul 2021. Photographs alongwith the family members are required to be carried and produced whenever asked for. Relationship certificate of the candidates should be issued by Records Office concerned duly signed by an officer of the concerned Records in addition to CRO/SRO indicating the full details of the officer's Personal No, Rank, Name and Appointment. Certificate issued by any other agency will not be accepted. Relationship Certificate issued by **DSC Records** will also be **not** accepted. In case the relationship certificate indicates issue of such certificate to any other brother / son of Serviceman / Ex-serviceman, the sponsor will require to furnish an affidavit of Rs 10/- of non judicial stamp paper, duly signed by First Class Magistrate or Notary, certifying that previous sponsorship of son / brother for recruitment in the Army has / has not resulted in successful enrolment of his sponsored candidate in (Arm/Service) (Performa as per **Appendix 'B'** attached).

(k) **Affidavit.** On Rupees 10/- Non Judicial Stamp Paper from Notary (Performa as per **Appendix 'C'** attached).

(l) **Photographs.** 20 Passport size latest colour photographs of self (Polaroid camera photos and computer photos will not be accepted). One copy of family photo of all members (size 6"x4") duly signed / verified by the Village Sarpanch / Gram Pradhan and affixed with his / her rubber stamp are accepted. Computerized mixed up family photos or computerized background of photo are not accepted. The family photo should include details of family members in the photographs in English only such as father, mother, self, brothers & sisters with date of birth authenticated by Village Sarpanch / Gram Pradhan along with ID proof (eg – AADHAR and PAN etc). **Format attached at Appx 'D'**.

(m) **Kandi Area Certificate.** Kandi Area Certificate issued by the SDM for personal belonging between Punjab & Himachal Pradesh Border(if applicable).

(n) **AADHAR and PAN Cards.** Candidate should be in possession of AADHAR and PAN Cards and bank account.

(o) **Monthly pay slip and family details portion of FS documents /** family details of sponsor printed from Army Intranet duly signed by an offr of the unit in case of serving person.

(p) **Discharge book in original of sponsor in case of Ex Servicemen / Widow / War widow.**

(q) **Army enrolment being a Central Government organization, all documents are required to be in Hindi or English language only.**

(r) **Consent Certificate.** Candidate between 17 ½ to 18 years on the date of screening should bring "Consent Certificate" from their parents on affidavit of notary stating that they are willing for enrolment of their son in the Army and will not claim for compensation for any injury caused during screening.

(s) **Outstanding Sportsmen.** Eligible outstanding sportsmen for open category are required to report Gate No 5, ASC Centre (North) – 1 ATC, Bengaluru-07 at 0530h on 03 Jan 2022 alongwith following **all original documents** and **two set of attested photocopies** as mentioned in Para 3 (a) to (p) above.

6. In case there is a variation in particulars of candidate's who claim to be SOWW/SOW/SOEX/SOS for the purposes of entitlement of relaxation in physical standard and bonus marks for overall merit, the under mentioned will be followed :-

(a) The particulars like age, name of the father and date of birth as listed in the education certificates will be final for the purpose of enrolment.

(b) In case of acceptable / minor variation in the individual's name, father's / mother's name, surname and date of birth etc as shown on the education certificate of the candidate vis-a-vis in the documents of serving soldiers / ex-serviceman / widow / war widow, the bonafide of the candidate will need to be established. For the same, an affidavit of Rupees 10/- non judicial stamp paper (Performa as per **Appendix 'E'** attached) duly signed by First Class Magistrate or Notary will be submitted before the candidate is granted the benefits of being son / brother of serving / retired soldier. The said affidavit will be submitted by the father of the individual or mother in case of a widow.

7. **Age Criteria.** As per Dte Gen Rtg B (A), IHQ of MoD (Army letter No 62554/Rtg B (A) dt 01 Oct 2020 and letter of even No dt 23 Nov 2020 "all UHQ rallies to consider 01 Oct of the ongoing rtg yr as the date for calculation of DOB for max eligible age and 01 Apr of the ongoing rtg yr as the date for calculation min eligible age". 8. **Variation of Date of Birth.** The variation between date of candidates as mentioned in their education certificate and documents available with Records Office of Regiments/Corps /Training Centre in respect of SOS/SOEX/SOWW and brother of serving/retired soldiers to be dealt in the following manner :-

(a) **Minor Variation.** A difference of 366 days in between birth certificate/civil education certificate and Relationship Certificate/date of birth given in service document is treated as minor variation e.g if the date of birth of a candidate mentioned in birth certificate/education certificate is 10 Jun 1994, then any date of birth given in service documents of father /brother of the candidate falling between 10 Jun 1994 and 10 Jun 1995 (both dates inclusive) is accepted as minor variation and an affidavit is required as per Appx 'D' to this letter.

(b) **Major Variation.** A difference beyond 366 days between the date of birth mentioned in education/birth certificate of candidate and Relationship Certificate/Date mentioned in service documents is treated as major variation. Hence the candidates having major variation in date of birth as mentioned above will NOT be entertained in UHQ Quota Rally.

9. **Variation in Candidates Name/Father's & Mother's Name and Date of Birth.** The particulars of age, name of father, name of mother and date of birth as mentioned in 10<sup>th</sup> class certificate will be taken as final for the purpose of enrolment. In case there is a variation in date of birth (upto 366 days only), indls name, Father's name /Mother's name, surname (Spelling variation may be accepted as long as the name remains the same. Similarly when the surname has been included in one certificate but not included in the other, it may also be accepted as long as the name is same. In no circumstance will an entirely different name in one of the certificate be accepted) etc as shown on the 10<sup>th</sup> class certificate vis-à-vis relationship certificate will need to be established. Affidavit on Rs 10/- non judicial stamp paper duly countersigned by Notary is required. The affidavit will be submitted by the father of the indl or mother in case of a widow if the candidate is below 18 years. If the candidate is 18 Yrs and above he will be required to submit the affidavit.

10. **Tattoos.** "Permanent body tattoos are only permitted on inner face of forearms i.e. From inside of elbow to the wrist and on the reverse side of palm/back (dorsal side of hand. Permanent body tattoos on any other part of the body are not acceptable and candidates will be barred from further selection. Tribes with tattoo marks on the face or body as per their existing custom and traditions will be permitted on a case to case basis"

(a) The above marks are fixed depending upon the eligibility of a candidate and have no relation to this performance in Common Entrance Exam (CEE). Only one type of bonus marks (Maximum of the permissible) will be added to the total after getting passing marks. No bonus marks are to be allotted unless the certificate (relationship/sports/NCC) have been verified.

(b) Provisional certificate for NCC cadets can be accepted during the recruitment rally as the final NCC certificate issued by NCC Directorate, may be issued late. However, the candidate has to produce the original certificate well before CEE to enable verification of the original certificate. An undertaking will be taken from the candidate that if the certificate is not verified before the conduct of CEE, Candidate will be allowed to appear for CEE only once the NCC certificate has been verified by the NCC Directorates of the State.

18. **CANDIDATES NOT IN POSSESSION OF ORIGINAL DOCUMENTS AS REQUIRED WILL BE REJECTED. PROVISIONAL CERTIFICATES WILL NOT BE ACCEPTED. CANDIDATES ARE ADVISED TO RECHECK THE REQUIRED DOCUMENTS BEFORE REPORTING AT THE RALLY LOCATION. NO REPRESENTATION WILL BE ACCEPTED AT A LATER STAGE.**

19. All candidates are advised in their own interest to get themselves medically examined before coming for selection for flat foot, vision and minor ailments. They are also advised to have the removed ears wax before reporting for recruitment rally.

20. Wards of civ employees who are paid out of Def estimates, BSF, Navy, Air Force, GREF and MES are not permitted to attend the said rally. Only wards / brothers of serving / ex-serviceman are permitted to attend the said recruitment rally.



21. Candidates must take care of their documents / belongings against any theft during the rally. Recruitment agency is not responsible for any loss / theft.

22. Candidates are advised not to approach any Private Recruitment Agency or touts (Dalal) for any help as recruitment is a free service.

23. Candidates are liable to be screened for use of physical performance enhancing drugs during recruitment rally. Army will not be responsible for any mis-happening during the run / other physical test due to consumption of drugs by the candidates.


24. **COVID-19 Protocol.** All candidates will be checked at the entrance gate for COVID protocols (like checking of Temp/BP), facemask and hand sanitizers. Candidates must be in possession of the following:-

(a) COVID-19 negative certificate of ICMR (Indian Council of Medical Research) approved laboratory issued not more than 72 hrs prior to the date of reporting. Candidates not in possession of the same will not be allowed to entry.

(b) Vaccination certificate for Age Gp 18 & above.
