Only those Players who had represented India / State / University or Junior / Youth State at present or have represented the same for the past 4 years need to apply. 

10. The Candidates who are already employed with any government department should send their applications "Through Proper Channel" only, failing which will be liable for rejection.

11. Selected candidates will be required to give an undertaking not to apply for inter-Commissionerate transfer for minimum period of 08 years.
